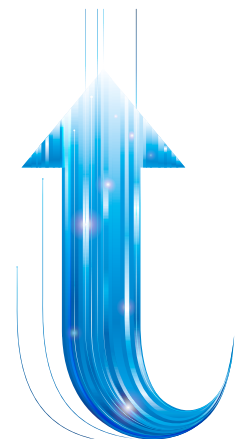

### From San Diego International Airport:

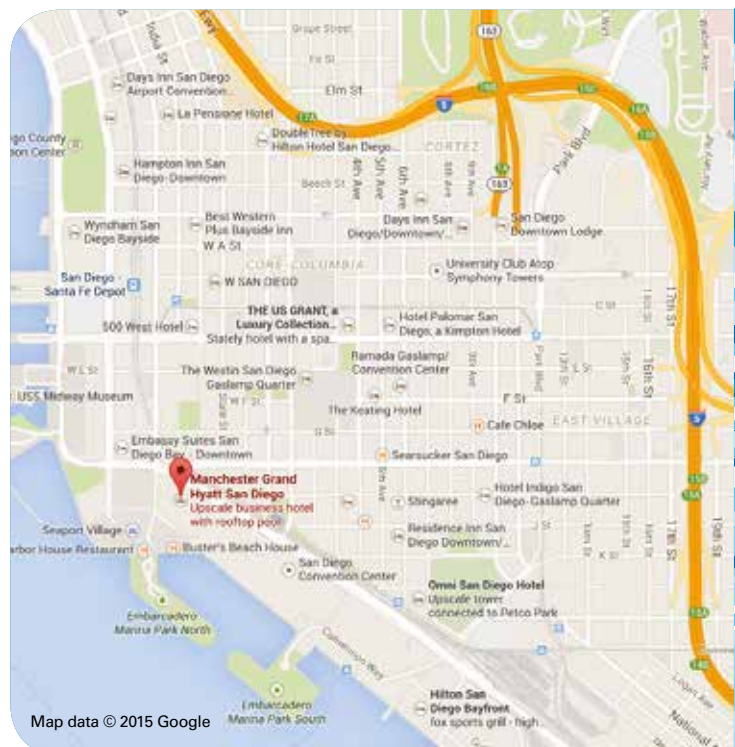
