

Physician Office Health Coach Training Program, Des Moines, IA

Physician offices are challenged with managing an ever-increasing number of patients with chronic conditions in a healthcare environment that demands improved quality of care at lower cost. By providing a medical home in the physician office setting, providers can improve the support of their patients, improve office workflow, and improve clinic patient outcomes. The Physician Office Health Coach is an innovative staff position that focuses on implementing Wagner's Care Model, assisting individual patients to improve self-management skills, and evaluating the overall effectiveness of health management in the primary care medical home.

This dynamic training program is designed to support the role of the physician office health coach by teaching practical skills in performing five major functions within the clinic office setting. They include: 1) using a disease registry, collecting, analyzing and reporting population-based clinical outcome measures 2) conducting pre-visit chart reviews for patients, 3) supporting patient self-management skills through health coaching techniques, 4) coordinating care, and 5) leading quality improvement processes for improved patient health management within their clinic.

PURPOSE

To develop the skills of selected physician office nursing staff to function as health coaches in support of improved patient self-management, to build leadership and facilitation skills in implementing Wagner's Care Model, and to lead quality improvement processes to increase overall effectiveness of the clinic practice.

By the completion of this program, participants will have experienced a combination of didactic learning, practical application and written and practical competency assessments. These are an integral part of the program and are designed to offer extended practice as follow-up to the all-day classroom settings.

COMPETENCY ASSESSMENT

Participants will complete the training program by taking a written exam and demonstrating their skills in individual health coaching. The written exam will consist of multiple choice questions over the materials presented in class. The coaching skills assessment will be a recording with simulated patients who are trained to play the role of actual patients. This experience is adapted to the specific goal of evaluating participants' skill in providing coaching consultation in a patient-focused setting.

Participants who pass the written exam with a minimum score of 70% and who receive a passing score on their patient interactive experience will be awarded with a Certificate of Competency.

TARGET AUDIENCE

Registered Nurses, Licensed Practical Nurses, and other clinic professionals who work with patients.

CONTINUING EDUCATION CREDIT

Nurses will be awarded CEUs by IBON Approved Provider #17 (Mercy Medical Center) for each individual day of the series. Participants who attend all sessions including the competency assessment will receive a total of 2.94 CEU.

- Explain the importance of creating a team to support Wagner's Care Model implementation

Future of Health Care / Accountable Care Organization (ACO)

- Describe the concepts of medical home and care coordination
- Recognize new and expanded responsibilities in the primary care setting
- Explore healthcare reform opportunities for improved health management

- Develop skills in asking simple and complex reflections
- Utilize OARS/EARS
- Recognize change talk expressed by patients
- Demonstrate how to provide information in a patient-centered manner

- Apply a PDSA cycle in your work setting

- Dialogue about experiences in the Coach role and the variety of adaptations in different clinic and transitions of care settings

Care Coordination

- Contrast acute care setting health management to that implemented in the ACO and the primary care medical home.

Making Sense of the TAV, SA's and SMS

- Apply MI to patient action plan development and to develop SMS
- Discuss tracking resources in health management

Day 3

Patient-Centered Health Coaching and Practice

- Explore and expand the use of change talk
- Compare outcome and behavioral goals
- Utilize SMART goals when coaching patients
- Apply motivational interviewing to develop individualized patient action plans, to optimize patient engagement, and to develop self-management support

Shared Decision Making

- Compare traditional medical decision making to shared decision making.

Health Literacy Concepts for Effective Patient Communication

- Demonstrate how to use plain language in written and oral patient communications

Community Resources

- Share local community resources that can promote patient well-being and independence.

Leadership and Team Building for a Successful Office Practice

- Apply principles of leadership during organizational transformation

Implementing the Role in Your Clinic

- Draft a vision for the position of Health Coach in your clinic

Prep for Competency Assessment

- Review key points of the course and the expectations for competency testing.

Health Coach Competency Assessments (Test and Recorded Interaction)

- Demonstrate health coach skill competency
- Discuss patient interaction observations
